1. The following terms and conditions apply to the Rewards Program of FASS Real Estate Services who has deemed the Member to be eligible to participate in the FASSperks Loyalty and Rewards Program and has issued the Member a Reward Card.
2. The Rewards Program (the "Program") awards "FASSBucks" to participants of the Program (each a "Member") who use/ present their FASSperks Resident Rewards Card ("Card") for eligible purchases and participation in promotions at/with the Merchant at a rate of accumulation of FASSBucks as set by the Merchant from time to time. FASSBucks may also be awarded based on other activities as designated by the Merchant from time to time. FASSBucks will not be awarded for purchases/actions made by the Member from the Merchant prior to enrolling in the Program.
3. FASSBucks are accumulated and may be redeemable for rewards in accordance with reward levels which are determined by the Merchant in its sole discretion. Once the Member has accumulated sufficient FASSBucks to earn a reward, the following may occur as determined by the Merchant in its sole discretion: a rewards coupon (the "Coupon") may be presented to the Member on the Member's sales receipt (the "Sales Receipt"), or the Merchant may allow the Member, upon request, to redeem FASSBucks for products and services. Upon the issuance of a Coupon or the redemption of FASSBucks, the Member's FASSBucks total will be reduced by the specified number of FASSBucks required for the reward being redeemed. All FASSBucks totals as shown on the Sales Receipt will be deemed to be correct, unless determined otherwise by the Merchant.
4. FASSBucks have no monetary value or any other benefit other than that described in these terms and conditions. For greater certainty, FASSBucks may not be redeemed for cash.
5. FASSBucks are not awarded and may not be redeemed on certain items sold by the Merchant including but not limited to: (a) any item where awarding or redeeming FASSBucks on the purchase of such item is prohibited by any law, rule, statute, regulation, order, judgment, decree, treaty or other requirement having the force of law; or (b) any other items specified by the Merchant from time to time in its sole discretion.
6. Every time the Member redeems rewards, the Member's FASSBucks balance along with the number of FASSBucks earned on the transaction will appear on the Member's receipt (the "Sales Receipt"). The Member's FASSBucks balance is also available online at: <http://balance.WorldPay.us>
7. The Member may only accrue FASSBucks to the account of the Member. FASSBucks may not be assigned, traded or otherwise transferred.
8. The eligibility of the Member to participate in the Program shall be determined by the Merchant in its sole discretion.
9. The Card remains the property of the Merchant. The Member is responsible for reporting misplaced, lost, stolen or damaged Cards to the Merchant. The Merchant is not responsible for rewards redeemed fraudulently through Cards that have been misplaced, lost, or stolen.
10. The Merchant shall maintain the privacy, security and integrity of all personal information the Member submits to the Merchant ("Personal Information").
11. The Merchant agrees that any Personal Information will be collected, used, disposed of and disclosed in accordance with the applicable laws, rules, and regulations.
12. By submitting the Personal Information to the Merchant or any of its service providers or agents, the Member consents and agrees that the Merchant may (i) collect, use and/or disclose Personal Information to communicate with the Member, to better understand the Member's shopping and information needs and to offer the Member relevant information, products, services and rewards to meet those needs; and (ii) allow limited and secured access to the Personal Information by authorized entities (including but not limited to FASS Real Estate Services) under its strict supervision solely for the purposes of supporting the Program.
13. The Member consents to and agrees that on occasion, the Merchant may communicate special offers, information and services to the Member.
14. If at any time, the Member wishes to withdraw from the Program, the Member shall return the Card to the Merchant along with a written request to the Merchant requesting that the Merchant deactivate the Member's FASSperks account. Upon withdrawing from the Program, the Member shall forfeit all accumulated and unredeemed FASSBucks. The Member acknowledges and agrees that the Card may be deactivated by the Merchant after a period of inactivity, as determined by the Merchant in its sole discretion, and that a deactivated Card may not be reactivated. Upon deactivation of the Card, the Member shall forfeit all accumulated and unredeemed FASSBucks.
15. Any disputes regarding the Program will be resolved by the Merchant in its sole discretion (including but not limited to disputes regarding the interpretation of these terms and provisions or any administrative or other procedures as may be established by the Merchant from time to time). All determinations made by the Merchant in connection with the Program shall be binding on the Member.
16. The Merchant shall not be liable to the Member in any way or in any manner whatsoever for any direct or indirect claims, losses, costs, damages or expenses (the "Damages") caused by or arising from the Member's participation in the Program including, without limitation Damages which arise as a consequence of any breach by the Merchant of its obligations herein, whether or not the Merchant knew or had reason to know that such Damages might be incurred.
17. The Merchant reserves the right to amend these terms and conditions from time to time or terminate the Program at any time. Termination of the Program will result in forfeiture of all FASSBucks without compensation unless the Member redeems the FASSBucks within thirty (30) days of the termination of the Program.
18. Any failure of the Member to comply with any of these terms or conditions or any violation, fraud or abuse of the Program may result in forfeiture of all FASSBucks and possible termination of the Member's account without compensation.
19. FASS Real Estate Services reserves the right to cancel, change or substitute offers of the Loyalty Program at any time, without notice. Members should retain all receipts or proof of participation in case of discrepancy.
20. FASSBucks can only be earned and rewarded during restricted promotional periods. We will announce deadlines, terms and conditions for earning rewards. FASSBucks will not be rewarded for promotions past deadline.
21. Must be a current resident in a FASS-managed property to earn FASSBucks and redeem rewards.
22. To participate in Special Incentive programs, your monthly cash portion of rent must be 2x the value of the prize.
23. FASS may, in its sole discretion, cancel or, from time to time, alter any part of the FASSperks Resident Rewards Program, the FASSperks Resident Rewards Program Rules, the FASSBucks accrual structure, or any FASSperks rewards at any time, and may offer alternate or supplemental rewards.
24. FASS reserves the right to change the FASSperks Resident Rewards Program rules, regulations, awards and offers at any time without notice, including the right to, among other things, modify or cancel any award or offer.
25. FASS may make these changes even if use of accumulated FASSBucks or awards is affected.
26. The accumulation of FASSBucks does not entitle any vested rights. FASS's exercise of this right shall be without any liability, obligation or additional compensation of any kind.
27. FASS's cancellation or termination of the FASSperks Resident Rewards Program will result in an automatic termination of this Agreement.
28. By signing or accepting this application form, the Member acknowledges and agrees to be bound by these terms and conditions.
